INDEPENDENT AUDITOR'S REPORT

Opinion

We have audited the accompanying financial statements of Eight Days of Hope, Inc. (a nonprofit organization), which comprise the statement of financial position as of December 31, 2022, and the related statements of activities, functional expenses and cash flows for the year then ended, and the related notes to the financial statements.
